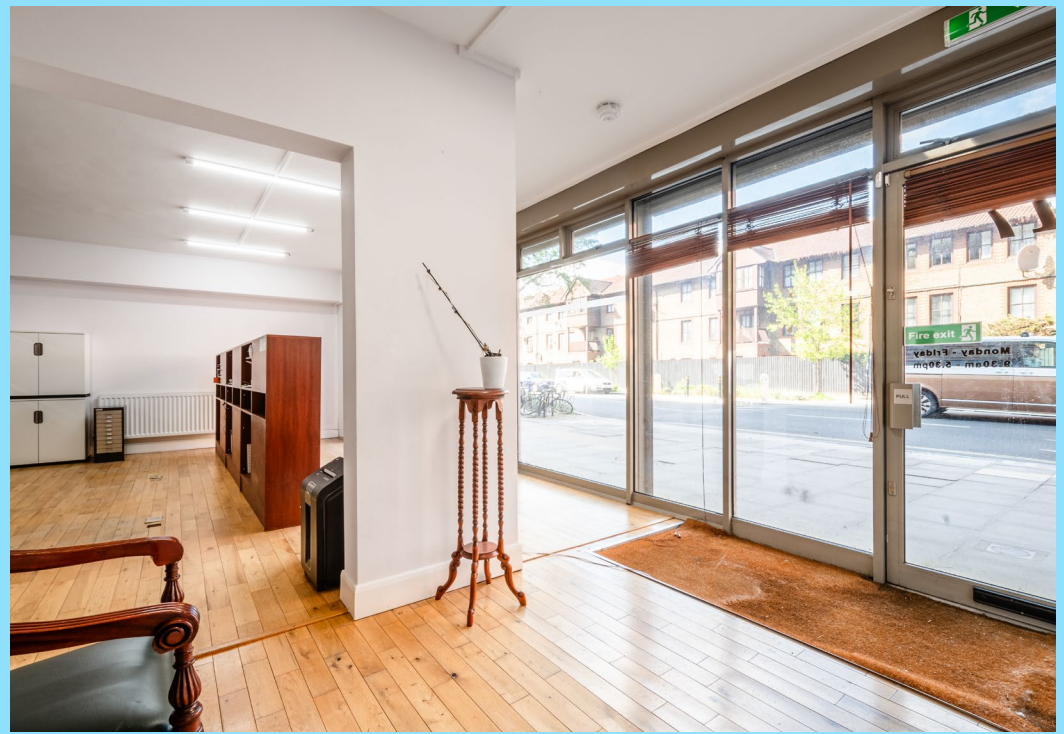

LOCATION

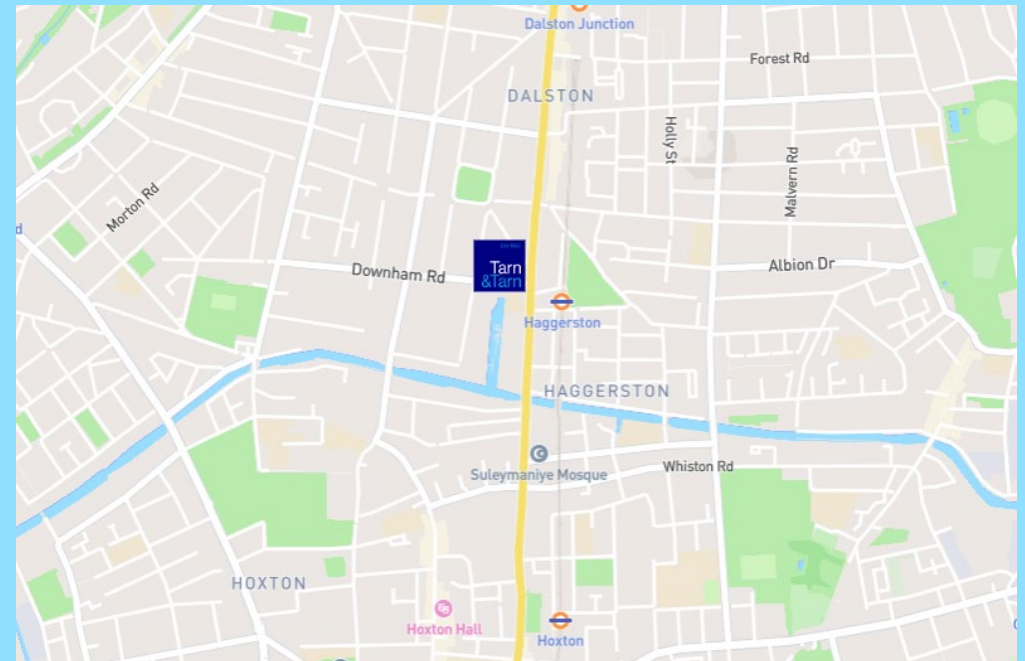
THE AREA
